I/we hereby declare that _____ [full name of the Candidate, Tenderer etc.] shall manufacture and supply the burnt clay bricks which shall comply with the following outline specifications:

1. Size of brick shall be 9" x 4.5" x 3"
2. Bricks shall be of first class quality
3. Bricks shall be of uniform and bright color
4. Bricks shall be of even and regular shape without undulations. They shall have sharp and truly right angled corners
5. Bricks shall have fine, dense and uniform texture. The fractured surface shall not show fissures, cavities, loose grit and un-burnt lime
6. Bricks shall give a sound metallic sound when struck with a hammer or with another brick
7. The crushing strength of the bricks shall be at least 1000 psi.
8. Bricks shall be hard enough to resist breakage when dropped from a height of 3 to 4 ft.
9. After immersing bricks in cold water for 24 hours, water absorption of bricks shall be not more than 1/16 of their own weight when dry.
10. Bricks shall not show white patches when soaked in water for 24 hours and then allowed to dry in shade. This shall show that the bricks are free from the presence of harmful sulphates of calcium, magnesium, sodium and potassium
11. Bricks shall have low thermal conductivity
12. Bricks shall provide better sound insulation
13. Bricks shall be fire resistant
